**Financial Commentary**

The cash flow is in line with the estimated cash flow from the last quarter 4C. During the first two quarters, the company incurred major Research & Development costs to finalise the core software platform that houses the algorithm and other analytics. For the remainder of the year, Research & Development expenditure will be substantially less, and will be incurred on progressing the hardware component of overnight monitoring.
